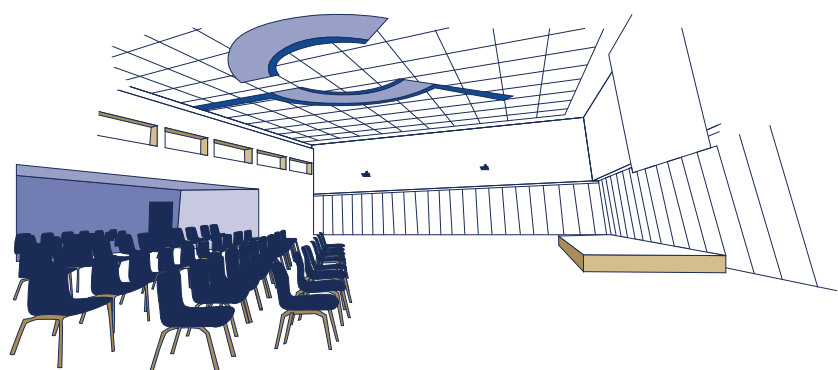
Dear Members,
